

## La Mesa RV Shows at the Pima County Fairgrounds: KNOW BEFORE YOU GO

**How much does it cost to park and to enter?:** *FREE*

**What are the hours of the show and sale?:** 9:00 a.m. – 6:00 p.m.

**Will there be food and beverages available to purchase:** Yes!

**Will Social Distancing be required?:** *Yes. Bathrooms and concession stands will have 6-foot markers and signage. RV or 5<sup>th</sup> wheel walk thru are limited to the customer and one salesperson at a time. Building capacities may also be limited.*

**Will face coverings be required?** *Yes. Per Pima County Resolution.*

**Does everyone have to wear a face covering?** *No. Some people are exempt; Children under 5, individuals with certain medical conditions, the hearing impaired or who are communicating with the hearing impaired, where the ability to see the mouth is essential for communication. Other individuals and circumstances are exempt. See the list of exemptions on the Pima County Resolution.*

**When is ok to remove my face covering?** *When you are eating or drinking. Other exemptions apply and can be read from the Pima County Resolution.*

**I have a disability. How will you accommodate me?** *Please call our disability advocate at 520-762-9104 or [Launa@PimaCountyFair.com](mailto:Launa@PimaCountyFair.com) so that plans can be put into place, prior to your arrival. Please give 24 hours for a response*

**What safety measures will be in place?** *The event will be staffed with security, bathrooms, tables, and counters, RVs and 5<sup>th</sup> wheels will be cleaned regularly, handwashing and hand sanitizing will be located throughout the event.*

**What else do I need to know?** *All guests must pass thru a Health Screening for entry. Failure to abide by the rules set forth per Pima County Resolution 2020-96 with regards to face coverings and social distancing, while at events at the Pima County Fairgrounds, may result in civil fines, being ejected from the property and/or civil fine, regardless if a spectator, participant, volunteer etc.*

**COVID-19 Warning and Assumption of Risk:** The Pima County Fairgrounds is working with Pima County to take proper precautions to keep our staff and guests as safe as possible while visiting the Pima County Fairgrounds and RV Park. An inherent risk of exposure to COVID-19 exists where people are together in any public place. COVID-19 is an extremely contagious disease than can cause severe illness and even death. Per the CDC, senior citizens, and people with underlying health or medical conditions are especially vulnerable. By visiting the Pima County Fairgrounds and RV Park, you are voluntarily assuming all risk related to the exposure of COVID-19.

**Some people are more likely than others to become severely ill from Covid-19,** such as older adults or people with medical conditions. Additionally, there may be others who need to take extra precautions because of certain other factors that put you at higher risk. For those people who are in these risk categories, the CDC recommends limiting contact with others, including avoiding large gatherings.
